

CARL D. CONE, 1940, of the University of Kentucky has completed *The Youth of Modern Sports* to be published in the fall. He is a member of the executive council of the Southern Historical Association.

VERGIL S. FOGDALL, 1947, has retired after 27 years at Lewis and Clark College, Portland, Oregon, where he was professor of history and for many years dean of admissions. In retirement he is serving as a consultant in admissions at Marylhurst Education Center which is achieving national recognition as a college for lifelong learning. Fogdall is currently continuing as executive secretary for the Oregon and Southwest Washington Conference of Historians.

AUBREY C. LAND, 1948, research professor at the University of Georgia, gave the keynote address, Planters of the Colonial Chesapeake, at the Conference of Eastern and Southern Decorative Arts in July 1979. The European edition of his *Bases of the Plantation Society* will be published this year by the Harvester Press (London).

EUGENE M. EMME, 1949 now director of Clio Research Associates, edited *Twenty-Five Years of the American Astronautical Society, 1954-79*, AAS History Series, Volume 2, and organized and chaired a AAS History Committee session, "New Perspectives on American Astronautics," at the Goddard Memorial Symposium, Washington, D.C., March 27-28, 1980. He delivered the fourth annual AIAA History Lecture, Six Space Age Presidents, at the annual meeting of the American Institute of Aeronautics and Astronautics, Baltimore, Maryland, May 7, 1980. He has book reviews in the *Journal of the Astronautical Sciences, Technology, and Culture*, and the *Catholic Historical Review*.

KEACH JOHNSON, 1949, of Des Moines published a two-part article "Elementary and Secondary Education in Iowa, 1890-1900" and "Time of Awakening" in the *Annals of Iowa*.

WALTER F. PETERSON, 1951, continues as president of the University of Dubuque.

NORBERT J. GOSSMAN, 1952, of the University of Detroit, coedited and wrote the introduction to volume one of the *Biographical Dictionary of Modern British Radicals, 1770-1830*, published by Harvester Press in 1979.

HARRY M. HUTSON, 1952, chairman of the department at the University of Tennessee at Martin, contributed an article on Jeremy Bentham to the *Biographical Dictionary of Modern British Radicals*, Vol. I (edited by J. O. Baylen and Norbert Gossman).

DWIGHT W. HOOVER, 1953, of Ball State University, has completed work on his illustrated history of Indiana to be published by the Indiana University Press in the fall. He served as consultant on an NEH-funded grant, "Middle-town," designed to produce a documentary film on Mun-

cie. He read a paper, "Toward a Social History of Muncie," at the Indiana Academy of Social Science in Bloomington. He coedited the fifth number of *Conspectus of History, Interpretations of History*.

GEORGE BREATHEITT, 1954, director of planning at Bennett College (North Carolina), received a grant from the U.S. Office of Education to conduct a consortium on research training in the humanities and social sciences. He was also appointed to the Review Committee for Postdoctoral Fellowships in History by the National Research Council (National Academy of Sciences).

LAWRENCE J. MCCAFFREY, 1954, of Loyola University, published "Poets, Priests, Peasants, and Politicians: New Perspectives in Irish History" in *Victorian Studies*. He is codirector of the Irish Studies Summer School at the University of Cork, Ireland.

DONALD WEINSTEIN, 1957, head of the department at the University of Arizona, served as commentator at a session of the American Society of Aesthetics and was a participant in a symposium sponsored by the Arizona Humanities Council, entitled "Who Runs the Country?" He is completing a book on the study of saints' lives.

GEORGE W. SIEBER, 1960, continues as chair of the department of History, University of Wisconsin at Oshkosh.

ROBERT D. LINDER, 1963, of Kansas State University has published "Evangelical Fortunes in Yugoslavia: Recent Developments in Theological Education" in *Christianity Today* and two essays in Carol G. Brownlee ed., *Faith and Discipline* (Sterling, Kansas).

ROBERT G. CLOUSE, 1963, of Indiana State University at Terre Haute has published *The Church in the Age of Orthodoxy and the Enlightenment, 1600-1800* (Saint Louis, Concordia, 1980) and has coauthored *Streams of Civilization, the Modern World to the Nuclear Age* (Milford, Michigan). He read a paper, "Apocalyptic Interpretation of Roman Catholicism in Seventeenth Century England," at the annual meeting of the Conference on Faith and History.

HUBERT H. WUBBEN, 1963, of Oregon State University, has contributed 14 biographical sketches on prominent Civil-War-era Iowans to the forthcoming *Biographical Dictionary of the Union* to be published by the Greenwood Press.

RICHARD V. PIERARD, 1964, of Indiana State University at Terre Haute had an active year. He published a high school text (coauthor Robert G. Clouse, 1963), *Streams of Civilization*, and several articles, including "The Bedfellows of Revival and Social Concern: Christian Social Action in Nineteenth-Century Germany" in *Christianity Today* and "Billy Graham and the U.S. Presidency" in *Journal of Church and State*. He lectured at the Chicago Theological Institute on Theology and Ethics after the

Holocaust and gave a paper, "German Missionaries and Volkish Thinking: Unwitting Affinity to Nazism?" at the midwestern section of the Evangelical Society of Church Society in March 1980.

DONALD NUGENT, 1965, associate professor at the University of Kentucky, spent the fall 1979 semester as a scholar in residence at the Institute for Advanced Theological Studies, Jerusalem.

ROBERT P. SWIERENGA, 1965, has had a busy year. His publications include: "Dutch Immigration Historiography" in *Immigration History Newsletter*; "The Dutch in America: An Overview" in *Dutch Americans: A Guide to Manuscript Sources* by Linda Pegman Doezema (Detroit: Gale Publications, 1979); "The Causes of Dutch Emigration to America: An 1866 Account" in *Michigana*; and "Physicians and Abortion Reform in the Nineteenth Century: Social Control as the New Orthodoxy" in *Fides et Historia*. Among his several papers, he read "Dutch International Labor Migration to the United States, 1835-1880" at the American Historical Association in New York. A revised version of this paper was presented to the Netherlandic Studies Conference on the History of Dutch Immigration to North America, University of Toronto, February 1980.

DAVID M. TUCKER, 1965, of Memphis State University, published *Memphis Since Crump* (University of Tennessee, 1980).

WELDON S. CROWLEY, 1966, Lucy King Brown Professor and chairman of the department at Southwestern University, has published "Erastianism in the Long Parliament, 1640-1646" in the *Journal of Church and State*.

RODNEY O. DAVIS, 1966, of Knox College, participated in an NEH seminar on the American West at the University of New Mexico and was on a panel at the OAH meeting in San Francisco.

HAMILTON CRAVENS, 1969, of Iowa State University, continues work on the Iowa Child Welfare Research Station and its role as a pioneering research institute in the period between the two world wars. He commented at a session of the Social Science History Association in Cambridge, Massachusetts; he gave a paper, "The Laura Spelman Rockefeller Memorial, the Child Welfare Institutes, and the Creation of the Science of the Child, 1917-1940," at the American Historical Association in New York; and he delivered four public lectures at Oregon State University on the history of racial mental testing in the United States.

THOMAS J. SCHLERETH, 1969, of the University of Notre Dame, served as the general program chairman for the regional studies in the Midwest conference held at the Chicago Historical Society. Among his many publications of the last year are the following: "The History outside the History Museum" in F.E.H. Schroeder, ed., *Twentieth*

*Century Popular Culture in Museums, Archives, and Libraries*; "Material Culture Studies in America: Notes toward a Historical Perspective, 1776-1976," *Material History Bulletin* (Ottawa); "Plants as Historical Evidence: The Natural Material Culture of the American Landscape," *Environmental Review*; and "Geronimo, the Last of the Apache Chiefs" in William D. Rowley, ed., *The American West* (1979). He also published a short architectural history on *The Notre Dame Main Building: Fact and Symbol, 1879-1979* (1979). During 1979-80, Schlereth presented papers at the national meeting of the American Studies Association at the Henry Francis DuPont Winterthur Craftsman in Early American History Conference, at the Chicago Historical Society, at the Cincinnati Historical Society, at the Art Institute of Chicago, and at George Washington University.

J. WAYNE BAKER, 1970, of the University of Akron has completed *Heinrich Bullinger and the Covenant: The Other Reformed Tradition* to be published this fall by the Ohio University Press. Among his several papers are "Zwingli and Oecolampadius on Discipline: The Origins of the Reformed Schism" presented at the fourteenth international Congress on Medieval Studies (Kalamazoo, Michigan); "Consensus or Dissensus? Bullinger and Calvin on Discipline in the Reformed Church in the 1550s" given at the annual meeting of the American Society of Church History; and "Covenant and Community in the Thought of Heinrich Bullinger" presented at the Federal Theology Conference (Philadelphia).

JOHN SOMMERVILLE, 1970, of the University of Florida was omitted inadvertently from last year's *Newsletter*. His publications include "English Puritans and Children: A Social-Psychological Explanation," *Journal of Psychohistory* (1978) and "Kids," *Today* (1979). He also presented a paper, "Boredom and Restlessness as Factors in History," at the Florida College Teachers of History conference this spring.

HAROLD SMITH, 1971, has been promoted to associate professor with tenure at the University of Houston Victoria Campus. During the past year he received a grant from the American Philosophical Society to support his research on the issue of 'equal pay for equal work' in Great Britain during World War II. He published "The Making of the Modern Woman: Women Workers, the Family, and Trade Unionism in Modern Europe" in *The Social Science Journal*.

JEANNE H. STEVENSON, 1972, received the Mullan Distinguished Teacher Award at the College of Notre Dame (Maryland). She is directing the project to study the ideas of Mother Theresa of Jesus, founder of the School of Sisters of Notre Dame.

JAMES L. THANE, JR., 1972, chairman of the department at Black Hawk College (Illinois), continues research on the history of the Montana Territory.

MICHAEL D. GREEN, 1973, of Dartmouth College published *The Creeks: A Critical Bibliography* (Indiana University Press). He read a paper, "Progressivism and Traditionalism in the Creek National Council, 1815-1835," at the American Society for Ethnohistory. His book, *The Politics of Indian Removal: Creek Government and Society in Crisis*, will be published by the University of Nebraska Press.

ROGER J. FECHNER, 1974, associate professor at Adrian College, delivered a paper, "Scottish Philosophy in Revolutionary America: John Witherspoon on Republican Virtue," at the east-central region of the American Society for Eighteenth-Century Studies.

MICHAEL J. HOGAN, 1974, has been promoted to associate professor at Miami University. His article, "Thomas W. Lamont and European Recovery, 1918-1924: The Diplomacy of Privatism in the Corporatist Age," will appear in a collection to be published by the ABC-Clio Press. He presently holds a grant from the Truman Library Institute and has been awarded a fellowship for the Woodrow Wilson International Center for Scholars, both for the purpose of completing his book on the Marshall Plan.

MARY KELLEY, 1974, of Dartmouth College edited *Women's Being, Woman's Place: Female Identity and Vocation in American History*. She lectured at Allegheny College and served on two review panels of the NEH.

ABRAHAM SCHERR, 1974, now holds a position at the Advanced Laser Technology Division, Air Force Weapons Laboratory, Kirtland Air Force Base, New Mexico. He continues work on an essay entitled "Reflections on the Defunct American Century."

JO ANN MANFRA, 1975, associate professor at Worcester Polytechnic Institute, Worcester, Massachusetts, has published "The Politics of Ultimate Ends: The American Catholic Episcopacy, 1789-1852" in *An American Church: Essays on the Americanization of the Catholic Church*, ed. David J. Alvarez (Saint Mary's College of California), and "Spiritual Authority v. Legal Authority: The Incorporation of Catholic Church Property, 1789-1911" (Mary Ingraham Bunting Institute of Independent Study, Radcliffe College). With Thomas Shannon she has co-authored *Bioethics and the Law: A Reader* to be published by the Paulist Press.

TRUDY HUSKAMP PETERSON, 1975, has been appointed chief of the legislative and natural resources branch of the National Archives and Records Service. This last winter the University of Nebraska Press published her book, *Agricultural Exports, Farm Income, and the Eisenhower Administration*. She also published three articles including one in *Law Library Journal* (November 1979), entitled "Archives Access and the Federal Freedom of Information Act."

MARC BAER, 1976, of Frostburg State College, received

an American Philosophical Society grant to do research in London on his project dealing with parliamentary elections in Victorian London. He was also a participant in an NEH summer seminar at Columbia University.

HARRY DAHLHEIMER, 1976, chairs the department at Cortland College, SUNY. In October he delivered a paper entitled "American Diplomats' Perceptions of Nazi Germany, 1933-37" at the annual Duquesne University History Forum.

MARVIN W. FALK, 1976, was reelected president of the Alaska Historical Society. He delivered the following papers: "Political Crimes: The Changing Role of the German Police in the Control of Criminal Political Behavior, 1910-1936" at the Academy of Criminal Justice Sciences 1980 annual meeting; "Historic Pre-1867 Maritime Maps of Alaska and the Arctic in the Elmer E. Rasmuson Library" at the Sea in Alaska's Past Conference held in Anchorage, Alaska; "Vitus Bering" to be published as one of the papers in the Captain James Cook bicentennial volume, *Explorations in Alaska*.

ALAN JANUARY, 1976, continues as research historian and editor of the *Biographical Directory of the Indiana General Assembly*. Volume one was published this spring.

ROBERT PALMER, 1977, terminated his postdoctoral fellowship at the University of Alberta after one year to take up a three-year postdoctoral appointment with the Michigan Society of Fellows at Ann Arbor, Michigan. This position carries with it affiliation with and some teaching duties in the law school of the University of Michigan. He delivered a paper entitled "The Emergence of a National Legal System in England" to the American Society for Legal History at Williamsburg, and his book, *The County Courts of Medieval England*, is currently being reviewed for publication.

JOHN SCHACHT, 1977, is a librarian in the reference department of The University of Iowa Libraries. He recently edited a volume entitled *Three Progressives from Iowa: Gilbert N. Haugen, Herbert C. Hoover, Henry A. Wallace* (Iowa City), consisting of papers delivered at a conference in 1979.

LOREN N. HORTON, 1978, serves as associate director of the State Historical Society of Iowa. He was appointed historical adviser for the State Preserves Board and he has given numerous papers on problems of family and local history and on historical preservation.

PHILLIP E. MYERS, 1978, assistant professor at Mankato State University, continues his research on Anglo-American relations in the nineteenth century.

GERALD W. PATTON, 1978, is assistant professor and assistant dean of the graduate school at Washington University. His book, *War and Race: The Black Officer in the American Military, 1915-1941*, is scheduled for publication by the Greenwood Press.

WILLIAM SILAG, 1979, compiled the biennial bibliography of computer-related historical research for the Modern Language Association forthcoming in *Computers and the Humanities*. He has written book reviews for that journal as well as *Mid-America* and the *Journal of American History*. Since October, he has edited the *Palimpsest*, the popular history magazine of the State Historical Society of Iowa.
