The rest of his time is occupied with promotion of the Goshen College peace studies chair endowment drive, attendance to the concerns of Mennonite Industry and Business Associates and the Mennonite Community Association, and prolonged consultations with the periodicals division of the Mennonite Publishing House.

ARTHUR G. UMSCHIED, 1935, although officially retired as dean of the Creighton graduate school, continued to teach on a part-time basis. His autobiographical article, "Academic Odyssey: From the Mississippi to the Missouri," which includes an account of his time at Iowa, appeared in a 1980 issue of the *Annals of Iowa*.

MERRILL G. BURLINGAME, 1936, reports that his book, *The Montana Frontier* (1942), has been reprinted by Montana State University Press.

HOMER L. CALKIN, 1939, spent three months in 1980 visiting seven countries in the South Pacific and East Asia under a grant for the National Endowment for the Humanities gathering information for a union catalog of archival and manuscript collections that pertain to the worldwide Methodist church.

CARL B. CONE, 1940, retired after 34 years of teaching at the University of Kentucky and will continue to reside in Lexington, Kentucky. His book, *Hounds in the Morning*, will be published in late 1981 by the University of Kentucky Press.

KENNETH R. ROSSMAN, 1940, retired after 34 years in the history department of Doane College. Doane College and his social fraternity, Delta Kappa Pi, jointly endowed a history chair in his name, and former students honored him with a *Festschrift: Historical Essays in Honor of Kenneth R. Rossman*, Kent Newmyer, ed. (Doane College, 1980).

ALFRED S. MARTIN, 1941, chairman and chief executive officer of the King Fifth Wheel Company of Mountaintop, Pennsylvania, plans to retire this year.

R. BRUCE HARLEY, 1948, continues as chief of the Office of History at Headquarters Fifteenth Air Force, March Air Force Base, California. In 1980 he updated and revised his *The March Field Story, 1918-1978* and coauthored two other publications: a booklet, *The Heritage of Fifteenth Air Force*, and a monograph on a Strategic Air Command exercise entitled "Global Shield 80: The Role of 15 AF."

AUBREY C. LAND, 1948, research professor at the University of Georgia, has published *Colonial Maryland: A History* (KTO Press) and has accepted the post of interim editor of the *Georgia Historical Quarterly*.

EUGENE M. EMME, 1949, served as cochairman of the history committee of the International Academy of Astronautics. While attending a symposium at the Institute of History of the U.S.S.R. Academy of Sciences on the twentieth anniversary of the first manned space flight, he was awarded the Tsiolkovsky History Award along with the Soviet Union's new cosmonauts. He served as

principal consultant for a Time-Life Book, *Architects of Air Power*, which will appear in the Epoch of Flight Series; his article, "Presidents and Space: From Eisenhower to Carter," will appear in *Perspectives in Astronautics*, volume 3 of the AAS History Series, of which he remains editor. His commentary, "More Books on Space," appeared in the *Wilson Quarterly*, spring 1981, and book reviews appeared in *Technology and Culture* and the *Journal of the Astronautical Sciences*. The British Library recently requested permission to copy his UI doctoral dissertation, *German Air Power, 1919-1939*, which is now 30 years old.

WALTER F. PETERSON, 1951, continues as the president of the University of Dubuque.

DWIGHT W. HOOVER, 1952, of Ball State University, published *A Pictorial History of Indiana* in late 1980. His history department lecture "A Paradigm Shift: The Concept of Race in the 1920s and 1930s," will appear in the *Conspectus of History*, volume 1, no. 7 late this year, as will his chapter on the history of churches in Muncie in *All Faithful People*, the second volume of Middletown III studies. He read two papers—"Social Order in Middletown, 1845-1975," at the fifth annual Social Science History Association meeting at Rochester, New York, in November and "Maintaining Order in Middletown, 1845-1975" at the Academy of Criminal Justice Sciences in Philadelphia in March with John Hewitt. The papers will be combined in an article scheduled to appear in *Law and Human Behavior* later this year. He chaired a session, "Urban History," at the Indiana History Conference in Indianapolis in November and commented on the papers at a Mormon history session at the American Historical Association. He chaired the official opening of the Center of Middletown Studies in November and was chosen outstanding faculty member by Gold Key honorary in February.

HARRY M. HUTSON, 1952, continues to serve as chairman of the Department of History and Political Science at the University of Tennessee, Martin.

GEORGE BREATHETT, 1954, of Bennett College, North Carolina, served as a commentator at the annual meeting of the Organization of American Historians and served as director of a 13-college consortium on research training in the social sciences and humanities.

LAWRENCE J. MCCAFFREY, 1954, of Loyola University, published "A Profile of Irish-America" in David Noel Doyle and Owen Dudley Edwards, eds., *America and Ireland, 1776-1976* (Greenwood Press, 1980); "O'Connell and the Irish-American Nationalist and Political Profiles," in Donal McCartney, ed., *The World of Daniel O'Connell* (Cork & Dublin, Mercier Press, 1980); essays on Bernadette Devlin and the personality of Irish-America in the *Chicago Tribune*; and reviews in the *AHR*. He appeared several times on the five-part Thames TV show on Northern Ireland, "The Troubles," which recently appeared in Britain, and lectured at the University College, Cork Irish Studies Summer School in Ireland, at Marquette University, at the Irish Arts Festival in Toledo, and for the Chicago Public Library System.

DONALD WEINSTEIN, 1957, of the University of Arizona is completing his book (with Rudolph Bell) on saints and society. He participated in an AHA-sponsored panel, "The Introductory Course," at Annapolis, Maryland, and a panel "The Place of History in the Undergraduate Curriculum: What Is to Be Done?" at the OAH in Detroit in April.

GEORGE W. SIEBER, 1960, of the University of Wisconsin, Oshkosh, has prepared articles on the history of forests in Iowa and Wisconsin for the forthcoming *Encyclopedia of American Forest and Conservation History* (Free Press).

ROBERT G. CLOUSE, 1963, of Indiana State University, was elected chairperson of the faculty senate and served as a director of the Eugene V. Debs Foundation and as a member of the board of editors of the Brethren Encyclopedia. He published "Apocalyptic Interpretation of Roman Catholicism in Seventeenth Century England" in *Fides et Historia*, fall 1980, and edited and contributed to a book, *War: Four Christian Views* (Inter-Varsity Press, 1981). His textbook, *Streams of Civilization: The Modern World to the Nuclear Age. A World History Text for High School Students*, was chosen as an outstanding book of the year by *Eternity* magazine.

ROBERT D. LINDER, 1963, of Kansas State University, published two articles: "History and the Christian Believer" and "The Christian Intellectual and the Ministry of the Mind: Three Case Studies from the Reformation" in C. G. Brownlee, ed., *Faith and Discipline* (Sterling, Kansas: Sterling College, 1980). He presented papers to the annual meetings of the American Academy of Religion and the American Society of Church History and is currently at work on biographies of Pierre Viret, the Calvinist reformer, and Frank Carlson, former U.S. senator from Kansas.

RICHARD V. PIERARD, 1964, of Indiana State University, published three articles: "Billy Graham and Vietnam: From Cold Warrior to Peacemaker," *Christian Scholars Review*, 1980; "The Church of the Brethren and the Temperance Movement," *Brethren Life and Thought*, winter 1981; "An Innocent in Babylon," *Christian Century*, February 25, 1981; he presented a paper, "Culture and Civilization: A Christian Critique of Oswald Spengler's Cultural Pessimism," to the Conference on Faith and History in Chicago, September 1980; a paper entitled "They'd Rather Be Right: Protestant Support for the Political Right in Weimar Germany and Post-Watergate America" to the American Society of Church History, Waco, Texas, April 1981; and the lecture "The New Christian Right" at Bluffton College, Ohio, and the Conservative Baptist Theological Seminary, Denver. He also participated in seminars and panels at the annual meeting of the American Historical Association, at the Center for the Study of the American Experience at the University of Southern California, at the conference of the Coalition for Christian Outreach in Pittsburgh, March 1981, and at the national conference "Evangelical Christians and Jews in an Age of Pluralism," Deerfield, Illinois, December 1980.

DONALD NUGENT, 1965, of the University of Kentucky, published *Masks of Satan: The Demonic in History* (London, 1981).

ROBERT P. SWIERENGA, 1965, of Kent State University, published six articles: "The Dutch" in *Harvard Encyclopedia of American Ethnic Groups*, edited by Oscar Handlin and Stephan Thernstrom (Harvard, 1980); "Behavioralism in Historical Research," in *Conspectus of History: Focus on Interpretations of History*, edited by Dwight W. Hoover and John Koumoulides (Cambridge University Press, 1978); "Local-Cosmopolitan Theory and Immigrant Religion," *Journal of Social History* (fall 1980); "Ethnicity and American Agriculture," *Ohio History* (summer 1980); "Immigrant Data Files and Computer Mapping," in *Data Bases in the Humanities and the Social Sciences*, edited by J. Raben and G. Marks (Amsterdam: North Holland Publishing Co., 1980); and "Dutch Immigrant Demography: 1820-1880," *Journal of Family History* (winter 1980).

WELDON S. CROWLEY, 1966, of Southwestern University, developed and conducted a symposium, "Macrohistory: Cosmopolitanism on a Global Scale," featuring W. H. McNeill, Kenneth Boulding, and Garret Hardin.

DAVID C. LUKOWITZ, 1968, of Hamline University published "George Lansbury's Peace Missions to Hitler and Mussolini," in the *Canadian Journal of History*, April 1980, and read a paper, "Comparative Urban History: The Teaching of Values," at the American Historical Association's regional conference on the teaching of history (Houston, October 1980).

HAMILTON CRAVENS, Ph.D. 1969, of Iowa State University, now teaches part-time in a newly restructured doctoral and undergraduate program in the history of technology and science within his department. He has continued to work on two books, one on the Iowa Child Welfare Research Station, the other on the Laura Spelman Rockefeller Memorial's impact upon applied social science in the 1920s. He chaired a session, "The Ethical, Political, and Social Uses of Evolutionary Theory," at the annual meeting of the History of Science Society in Toronto in October. He gave a public lecture, "The Wandering I.Q.: A Historical Example," at the University of California, Berkeley, in November. He is working on a scholarly article on the psychologist Henry H. Goddard, a pioneer in mental testing and juvenile delinquency. He had an article published in the *Dictionary of American Biography* and several reviews published.

CARROLL ENGELHARDT, 1969, of Concordia College,

Moorhead, Minnesota, has published "Man in the Middle: Arthur M. Schlesinger, Jr. and Postwar American Liberalism" in the *South Atlantic Quarterly* (spring 1981).

THOMAS J. SCHLERETH, 1969, of the University of Notre Dame, served as general program chairman for a three-day conference, "Politics and Journalism, Chicago Style," held at the University of Notre Dame in October. He was appointed to the board of editors of the *Winterthur Portfolio: A Journal of American Material Culture* and to the committee on education by the American Association for State and Local History. In the past year his publications included "City Planning as Progressive Reform: Burnham's Plan and Moody's Manual," *Journal of the American Planning Association* (1981); "Past Cityscapes: Uses of Cartography in Urban History," *Newberry Library Papers in Family and Community History* (1980); "Mirrors of the Past Historical Photography and American History," *Exposure: The Journal of the Society for Photographic Education* (1980); "A Perspective on Criticism: Guidelines for History Museum Exhibition Reviews," *History News* (1980); "The History behind, within, outside History Museum," *Curator: The Journal of the American Museum of Natural History* (1981); "Mail Order Catalog as Resources in Material Culture Studies," *Prospect: A Journal of American Culture* (1981); *Artifacts and the American Past* (Nashville, Tennessee: American Association for State and Local History, 1980). During the period 1980-81, Schlereth presented research papers at the national meetings of the Organization of American Historians, the Social Science History Association, the American Association for State and Local History, the National Conference on Folklore and History, as well as presenting papers at the Delaware Art Museum, the New Haven Historical Society, Mount Holyoke College, and the Herman E. Smith Center for the Study of the History of Cartography Study.

GERALD W. WOLFF, 1969, of the University of South Dakota, edited the *Korean War Journal of Lloyd R. Moses* (Major General, U.S. Army, retired) for the *South Dakota Historical Collections* and wrote several articles for *Encyclopedia USA*, as well as several book reviews.

KIRK C. ALLIMAN, 1970, has been elected president of Hesston (Kansas) College by the Mennonite Board of Education, assuming responsibilities on July 1, 1981.

HOWARD A. BARNES, 1970, of Winston-Salem State University, participated in an NEH summer seminar on the Jacksonian period at the University of Illinois, Chicago Circle, wrote a review for *History: Review of New Books*, and is editing the third edition of the Winston-Salem State University *Social Science Journal*.

JOHN SOMMERVILLE, 1970, of the University of Florida, has two articles forthcoming: "The Anti-Puritan Work Ethic," in *Journal of British Studies*, and "Breaking the Icon: The First Real Children in English Books," in *History of Education Quarterly*.

NIEL M. JOHNSON, 1971, archivist at the Truman Library, coauthored an article, "Resources at the Harry S.

Truman Library on Western Issues and Programs" in volume 7A of *Government Publications Review*. Last fall he presented a slide program on nineteenth-century Missouri River history to visitors at Fort Osage, Missouri.

PHILIP D. JORDAN, 1971, of Western State College in Colorado, read a paper, "The Search for a Scientific Social Gospel, 1885-1914," to the Missouri Valley History Conference at Omaha in March 1980 and participated in a National Endowment for the Humanities sponsored seminar at the University of Maryland during the summer of 1980. His book reviews appeared in *Choice* and *Church History*.

PETER L. PETERSEN, 1971, was recipient of the outstanding member of the faculty award given annually by the student government at West Texas State University. He published three articles: "Oslo on the Texas High Plains," *Norwegian American Studies*; "From Denmark to America: A Review Essay," *Annals of Iowa*; and "Hard Times on the High Plains: FSA Photography during the 1930s," *Panhandle-Plains Historical Review*. A lengthy interview conducted in 1979 with photo editor and writer Edwin Roskam served as the basis for a recent Roskam memoir entitled "Not Intended for Framing: The FSA Archive," published in *Afterimage*.

HAROLD SMITH, 1971, of the University of Houston Victoria Campus, presented a paper, "Sex vs. Class: British Feminists and the Labour Movement, 1919-1939," at the Conference on British Studies (Rocky Mountain section), published book reviews in *Labor History* and the *Journal of Economic History*, and has been awarded the UHVC Summer Research Sabbatical for the summer of 1981. His article, "The Problem of 'Equal Pay for Equal Work' in Great Britain during World War II," has been accepted by the *Journal of Modern History*.

RONALD E. SWERCZEK, 1972, is now assistant chief for reference in the diplomatic branch of the National Archives. His essay, "Hugh Gibson and Disarmament: The Diplomacy of Gradualism," will appear in Kenneth Paul Jones, ed., *U.S. Diplomats: America's Search for Peace in Europe, 1919-1941* (ABC-Clio Press).

MICHAEL J. HOGAN, 1974, is spending most of 1981 working on his history of the Marshall Plan at the Woodrow Wilson International Center for Scholars in Washington, D.C. His article, "Thomas Lamont and European Reconstruction: The Diplomacy of Privatism in the Corporatist Age," will appear this June in a volume entitled *U.S. Diplomats* (ABC-Clio Press).

ABRAHAM SCHERR, 1974, began work at the Air Force Weapons Laboratory History Office in Albuquerque, New Mexico.

LATHAN A. WINDLEY, 1974, of Morgan State University, Baltimore, is currently preparing a book manuscript about runaway slaves in the eighteenth century for Greenwood Press, to be published in 1982.

ROBERT HUMPHREY, 1975, will begin his second year as visiting assistant professor at The University of Iowa next fall.

TRUDY HUSKAMP PETERSON, 1975, was cochair of the program committee for the annual convention of the So-

ciety of American Archivists in October 1980 and was named a fellow of the society. In December, Howard University Press published a volume which she edited, entitled *Farmers, Bureaucrats, and Middlemen: Historical Perspectives on American Agriculture*. Her article on the Freedom of Information Act ("After Five Years: An Assessment of the U.S. Freedom of Information Act") was selected as one of the best articles of 1980 on topics of interest to librarians and will appear in the Scarecrow Press anthology *Library Lit: The Best of 1980*.

MARC BAER, 1976, of Frostburg State College, Maryland, spent last summer in Great Britain on an American Philosophical Society grant to do research, and presented a paper on "Quantitative Strategies for Teaching European Urban History" to the 1980 meeting of the AHA.

MARVIN W. FALK, 1976, was awarded an NEH fellowship to attend the Summer Institute on the History of Cartography held at the Newberry Library in Chicago. Last spring he was promoted from assistant to associate professor at the University of Alaska. Presently on a year's sabbatical leave at Cambridge University, his work has taken him to Helsinki to work with the Russian collections there and to the Soviet Union.

ALAN JANUARY, 1976, continues as research historian and editor of the *Biographical Directory of the Indiana General Assembly*. This spring the Indiana legislature renewed the project through 1984.

MIRIAM DARCE FRENIER, 1978, of the University of Minnesota, Morris, is writing papers on Chinese land reform and American women antifeminists.

PHILLIP E. MYERS, 1978, of Mankato State University, wrote an article, "Ireland and Iowa in the 1880s," which is forthcoming in *Palimpsest*, and reviewed Oscar Handlin's *Truth in History* in *Annals of Iowa: A Quarterly Journal of History* (winter 1981). He has received a faculty grant to complete his manuscript, "Diplomacy of Paradox: An Interpretation of British Imperialism and the Path to the Treaty of Washington, 1815-1871."

JAMES ROBERTS, 1979, joined the faculty at Stanford as a teaching and research fellow in the fall of 1979 and is now a lecturer in the history department and part of the faculty of Stanford's newly created Western Culture Program. While revising his thesis on drink and temperance in nineteenth-century Germany, he has published several essays, and an article entitled "Drink and Industrial Work Discipline in Nineteenth-Century Germany" will appear this fall in the *Journal of Social History*. This past November he presented a paper at a conference in West Germany as the guest of the Arbeitskreis für moderne Sozialgeschichte in Heidelberg.

ADELE HAST, 1979, became editor in chief of the *Marquis Who's Who* directories. Prior to that time, she was associate director of the Historical County Boundary Data File Project at the Newberry Library. She spent one and one-half months in Great Britain in May and June 1980, doing research on American pre-Revolutionary War debts to British merchants, under a British Academy research fellowship. In July 1980, she was a member of the faculty of the Summer Institute on the History of Cartography at the Newberry Library. She presented a paper on maps in teaching and research at the Social Science History Association meeting in Rochester and a paper, "A Minority among Women: Loyalists in Revolutionary Virginia," at the OAH meeting in Detroit.

Graduate Student Awards

DAVID HAMILTON won the Louis Pelzer Memorial Award for his essay "Herbert Hoover and the Great Drought of 1930." This award is given annually for the best essay submitted to the *Journal of American History* by a graduate student. The winner receives a medal, a check for \$500, and publication of the article in the journal. Louis Pelzer received his Ph.D. from Iowa and taught in the department until his death in the 1940s.
